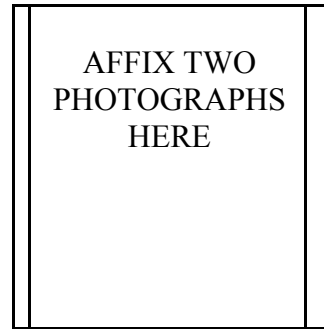

- (iii) Student Visa: Letter of admission from recognised school/college/university/educational institution in India
- (iv) Conference Visa: Letter of invitation from conference organisers in India
- (v) Employment Visa: Appointment/contract letter giving details of employment
- (vi) Journalist Visa: Letter from sponsoring/inviting agency or organisation giving details such as places to be visited, people to be interviewed etc.
- (vii) Transit Visa: Valid ticket for outbound journey from India. This visa is valid only for seventy two hours on disembarkation at the transit point in India for onward journey.
